Exhibitor Terms and Conditions

The SPCA Serving Erie County reviews vendor/exhibitor applications to ensure that all items and services complement our mission and do not directly compete with our sponsors. We reserve the right to deny any application that does not support our mission and/or is in direct competition with sponsors.

1. The SPCA will provide you with a stall for your booth space. Please note that some stalls have uneven surfaces. The stalls are inside the stables and covered from the elements.
2. Vendors can place their booths outside the stalls in an open field that will serve as our "vendor market". If you choose to have your space outside of the stalls, you must provide your own tent. A tent will not be provided.
3. Vendors and exhibitors must bring their own tables and chairs.
4. On average, approximately 700 people and 350 dogs participate in the event. Please be prepared if you are planning to give out any samples, coupons, etc.
5. You may arrive at the park as early as 6:45 a.m. to set up your space. Please have your space ready for business by 9 a.m. For loading in you may drive your vehicle around the circle to unload your items. **You must remove your vehicle from the vendor area by 8:15 a.m.** Registration begins at 9 a.m. and event participants may visit your booth before the start of the walk at 10 a.m. For the protection of our participants and their dogs who will be in the area, please do not close or dismantle your booth prior to 1 p.m.
6. You are responsible for removing your own trash. Garbage cans will be on-site.
7. Please do not leave your booth to sell items or distribute materials elsewhere within the grounds. In turn, we promise to prevent non-registered vendors or exhibitors from selling or distributing their materials.
8. Donation jars for any other non-profit organizations and the sale of any pets on or near the event grounds are strictly prohibited.
9. The SPCA requires all vendors to provide a certificate of insurance listing Erie County SPCA as additionally insured on an Insured Direct, Primary, and Non-Contributory Basis under the General Liability, Automobile, and Umbrella Policies.
10. As a vendor, it is your responsibility to collect and submit appropriate sales tax to the Town of East Aurora, Erie County, and the State of New York.
11. You are not authorized to "sublet" your booth in whole or in part.
